**ORDER**

**Indian Teacher Training College, Near Samaj Kalyan Hostel, Churu, Rajasthan** submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of B.Ed. Course in terms of section 14(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Indian Teacher Training College, Near Samaj Kalyan Hostel, Churu, Rajasthan** to conduct **B.Ed. Course** of One year duration with an annual intake of 100 (One Hundred Only) (One Unit) w.e.f. the session 2006-2007 at the following address:-

3. The institution shall ensure the fulfillment of the following: -

- The institution shall maintain the teaching staff strength of 1+7 for the proposed B.Ed. Course.
- The institution shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government. Etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- The institution shall regularly update its website.

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 **Indian Teacher Training College, Near Smage Kalyan Hostel, Churu, Rajasthan** has submitted an application (code No. 05165) to the Northern Regional Committee of NCTE for grant of recognition/permission for **B.Ed. Course** of one year duration with an additional intake of **100 (One Hundred Only)** students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Indian Teacher Training College, Near Smage Kalyan Hostel, Churu, Rajasthan** for conducting **B.Ed. Course** of one year duration with an additional intake in existing B.Ed. course of 100 (One hundred Only) (one unit), thereby making the total intake of the institution to 200 (Two hundred only) (Two Unit) under clause 7(12) of Regulation dated 13.01.2006 subject to fulfillment of the following:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

**ORDER**

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the institution i.e. **Indian Teacher Training College, Near, Samaj Kalyan Hostel, Churu, Rajasthan** has been recognized for B.Ed. course by NRC vide order No. F.NRC/NCTE/RJ-624/4148 dt 07.08.2006 for an intake of 200.

3. AND WHEREAS, the institution **Indian Teacher Training College, Near, Samaj Kalyan Hostel, Churu, Rajasthan** has by affidavit consented to come under New Regulations and sought for four basic units in B.Ed. which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have four basic units of 50 students each subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.


5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order **Indian Teacher Training College, Near, Samaj Kalyan Hostel, Churu, Rajasthan** for conducting B.Ed. programme of two years duration with an annual intake of 200 for four basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein, before 31.10.2015

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
  - (a) Sanctioned programmes along with annual intake in the institution.
  - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - (c) Name of faculty members who left or joined during the last quarter.
  - (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - (e) Fee charged from students.
  - (f) Available infrastructural facilities.
  - (g) Facilities added during the last quarter.
  - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - (i) The affidavit with enclosure submitted along with application.
  - (j) The institution shall be free to post additional relevant information, if it so desires.
  - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
